I understand:

- Probationary Membership is intended to be a temporary status of at least six (6) but not more than 12 months to allow the Club to determine whether the applicant would be desired as a Full Member.
- Probationary Members have no nominating or voting privileges, cannot hold office and cannot train on the club grounds unless a guest of a Full Member.
- All Club members are required to work a minimum of four (4) full days at Club hunt tests each calendar year and to complete at least two (2) scheduled grounds maintenance workdays each year.
- For Members with physical limitations, please notify the Board after you have been notified of your acceptance as a Probationary Member.
- After at least six (6) months from notification that this Application was received, the Probationary Member can apply to become a Full Member by asking at least two Full Members in good standing to endorse them in writing to the Board.
- If approved, the applicant will be notified and upon receipt of the annual dues, will become a Full Member. The annual dues can be found at yadkinriverretriever.com.

WARNING

I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, hereby release and hold harmless Yadkin River Waterfowl and Retriever Club, Inc., its directors, officers, officials, judges, agents, members, employees, other participants, sponsors, and/or owners and lessors of the Club premises and training facility ("**Releasees**"), with respect to any and all injury, disability, death, or loss or damage to person or property (including my canine(s)), whether arising from the negligence of the Releasees or otherwise, to the fullest extent permitted by law.
